Under these specific circumstances the deposit is refunded to Purchaser. Cancellation by purchaser for any reason does not warrant return of any deposit paid.
12. No performance by Roger Chartier pursuant to the contract shall be recorded, reproduced or transmitted from the place of performance in any manner or by any means whatsoever in the absence of a prior written agreement with Roger Chartier relating to and permitting such recording, reproduction or transmission.
13. Only the Purchaser shall have direction and supervision of the performance of Roger Chartier's services at this engagement. Roger Chartier hereby agrees to render his professional services and is at all times to have complete control of his program. Roger Chartier reserves the right to deny any guest access to the sound system, music recordings, or other equipment. Roger Chartier will make an extra effort to have recorded music requests available if they are received in writing or by confirmed e-mail at least two weeks prior to the engagement. Roger Chartier shall attempt to play Purchaser's and Purchaser's guests' music requests but shall not be held responsible if certain selections are unavailable. Vulgar and offensive music will not be played if deemed inappropriate by Roger Chartier.
14. Purchaser shall provide Roger Chartier with safe and appropriate working conditions. This includes an 8-foot by 6-foot area for setup of equipment and Roger Chartier. Roger Chartier requires a minimum of one 15-20-amp circuit outlet from a reliable power source within 50 feet (along the wall) of the set-up area.
15. Purchaser warrants that he or she is of legal age and has the right to enter into this contract.
